Location

Carlton Parade offers a mixture of retail and catering establishments.

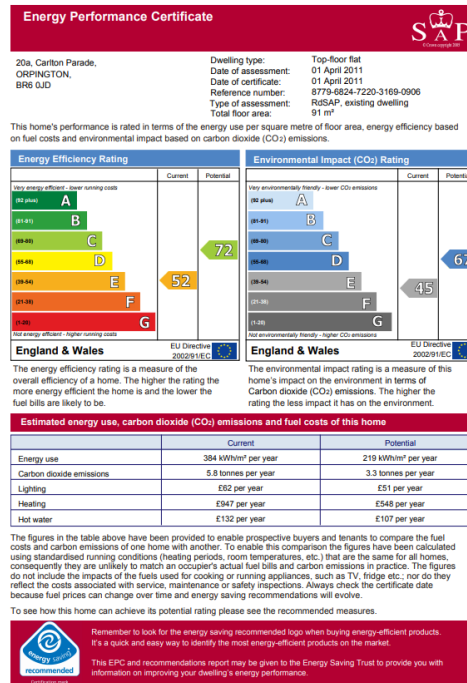
